



16.40 Urban Voids and Social Equity:
Overlaps and Gaps in Distributive
Problems.

The contribution examines how questions of equity (e.g. housing access) relate to distributive issues in cities (e.g. unused housing stock). It unpacks the various notions of "urban voids" in the literature and public debate, clarifying when problems and solutions may coincide and when they remain disconnected. <u>17.00 HouseEurope!, Towards a Right to Housing.</u>

HouseEurope! is a non-profit policy lab that advocates for the socio-ecological transformation of Europe's existing building stock. Currently, HouseEurope! is campaigning its European Citizens' Initiative (ECI) "Power to Renovation" that advocates for new laws to make the renovation and transformation of existing buildings the new norm and stop speculative demolition and replacement. To bring its legal proposal to the European Parliament, HouseEurope! is collecting 1 million signatures across Europe until February 2026. The contribution will explore the convergence of the housing and climate crisis in the built environment, the impact of cultural narratives on architectural policy, and the economic potential of the renovation of Europe.

17.20 Fragments of Taxonomies for Forgotten Voices and Empty Buildings Transformations.

The contribution will introduce an approach to the analysis and classification of empty buildings transformations and homeless youths that has episodically been lost by the mainstream urban and architectural profession and pedagogy. This allows the approach to reveal taxonomies, yet fragmented, and their glossary with its own latent trans-critical position anticipating our disciplines' capacity to join the rest of the humanities in bringing marginalised, suppressed or minoritarian voices to the fore.
