### The Dean

HAVING REGARD to the Decree of the President of the Republic 11.07.1980, n. 382 "Reorganization of university professors, their training range and organizational and educational experimentation", and subsequent amendments;  
HAVING REGARD TO the Law 19.11.1990, n. 341 "Reform of university educational systems";  
HAVING REGARD to the Law 30.12.2010, n. 240 "Rules on organization of Universities, academic staff and recruitment, authorizing the Government to enhance quality and efficiency of the university system";  
INVOKED to the current Statute of Politecnico di Milano;  
INVOKED to the current University General Regulation;  
HEARD the opinion of the Dean of the School of Architecture Urban Planning Construction Engineering;  
HEARD the opinion of the Dean of the School of Industrial Engineering and Information,

### HEREBY DECREES

#### Article 1

The issuance of this selection Call for participation in Double Degree projects - CdS of Laurea Magistrale in "Management of Built Environment – Gestione del Costruito LM-24" o CdS di Laurea Magistrale in "Management Engineering LM-31" for the academic year 2020/2021.

#### Article 2 Purpose

The double degree in Master Study Courses "Management of Built Environment – Gestione del Costruito LM-24" and in "Management Engineering LM-31" aims to train professionals who can strengthen the skills of a management engineer in relation to the specific industry, and provide the experts with the built environment with in-depth management skills. In this way students become more aware of the difficulties of building design, resource management, interaction between management issues and techniques at all stages of the construction cycle. In this connection, particular attention will be given to the problems of globalization of the market, management of innovation and logistics.

#### Article 3 Participation requirements

Application for participation can be submitted by 20 students of Politecnico di Milano who are enrolled, for the academic year 2020-21, to the Master of Science (equivalent to Laurea Magistrale) in "Management of Built Environment - Gestione del Costruito LM-

24 study plan: PSPA ME3 Economic Curriculum (penalty of exclusion) or Master of Science (equivalent to Laurea Magistrale) in “Management Engineering LM-31” study plan: IM Industrial Management (penalty of exclusion) - (10 students for each Master of Science).

Only applications that meet the criteria for access to both master's degree programs are admissible (see teaching regulations for degree courses in Management Engineering and Building Management). It should also be noted that admission to the Double Degree program is incompatible with the Erasmus program. If selected for both programs, candidates must confirm participation by choosing only one.

#### **Article 4 Application for participation and submission deadline**

Candidates have to submit their application at the following link: <http://www.polimi.it/servizionline> (Benefits and agreements > Economic benefits) not later of **12/11/2020**.

The applicant, under penalty of exclusion, must enclose the following documents (.pdf extension, max 10 MB) with the application form

Attach to the application:

- a) motivation letter;
- b) curriculum Studiorum of the Bachelor (included exams and abstract of the graduation work) or of the Master of Science (exam details, if available) Programmes;
- c) curriculum Vitae (With clear indication of other skills, professional experiences and hobbies);

The annexes to the application form must be written in English.

Files must be named with Surname-Name-Type of Document.pdf (for example Rossi-Mario-curriculum.pdf).

The successful online submission is equivalent to its delivery and requires the applicant to be aware of the information sent. It is under the applicant's responsibility to verify the successful online submission.

Failure to complete the application or lack of required information will result in the exclusion from the assessment procedure.

#### **Article 5 – Selection commission**

The selection commission is appointed by the School of Architecture Urban Planning Construction Engineering and it is made up of at least three professors of the study programme in Management of Built Environment – Gestione del Costruito LM-24” or “Management Engineering LM-31” chosen by the School.

Without the unanimity on the evaluation of candidates, the commission will ask for the unquestionable decision of the Dean of the School.

## **Article 6 - Assessment Criteria**

The Selection Board proceeds to the selection, which has a total of 100 points, by examining the documents submitted by the candidates and the individual interview.

The commission will make a first selection of candidates based on the academic background, motivational letter and CV of the candidate and will assign up to 60 points divided as follows:

- Motivation letter: 10 points;  
Academic CV of the Degree obtained at other universities, with self-certification of the examinations supported by the respective grades and the final grade, up to: 40 points;
- Personal CV and Thesis or Business Game experience, up to 10 points.

Candidates who get at least 42 points (equivalent to 7/10 of the score) will be admitted to the individual interview.

For only candidates admitted to the interview, the commission will make a second individual assessment that will evaluate:

- consistency of the Double Degree with the expectations and motivations of the candidate;
- consistency of the objectives of the Double Degree with the specific skills acquired by the candidate during the Bachelor and other experience of the curriculum;
- The motivation of the candidate to acquire knowledge in the areas covered by the Double Degree, particularly in reference to the second degree (assessed through questions during the individual interview).

At the individual interview, which will be held in English, a maximum of 40 points will be awarded.

At the end of the evaluations, a two-tier credit score will be drawn up (each for master's degrees) and all candidates who have reached a minimum score of 60 out of 100 will be admitted to the program until the maximum number is reached (10 students for each master's degree of origin).

To be admitted to the interview, candidates must have one of the following valid identity documents: identity card, passport or driving license.

The non-presentation at the place of the interview, on the date and time established, or late presentation, even if due to force majeure, will be considered as renunciation to participate in the selection.

This call is also a convocation notification for candidates.

### **Article 8** **Merit ranking list**

The Commission draws up, on the basis of the criteria and parameters set out in this call, a merit ranking list, taking into account the scores obtained in the evaluation of candidates.

### **Article 9** **Data Treatment**
