HAVING REGARD to the Law 30.12.2010, n. 240 "Rules on organization of Universities, academic staff and recruitment, authorizing the Government to enhance quality and efficiency of the university system";
CITED to the current Statute of Politecnico di Milano;
CITED to the current University General Regulation;
CITED the educational rules of the LaureaMagistrale Master programme in Building and Architectural Engineering;
CITED the educational rules of the LaureaMagistrale Master programme in Mechanical Engineering;

HEREBY DECREES

Article 1

The issuance of this selection Call for participation in Double Degree projects – Laurea Magistrale programme in "Building and Architectural Engineering" and Laurea Magistrale programme in "Mechanical Engineering" for the academic year 2019/2020.

Article 2

Purpose

The double degree in "Building and Architectural Engineering" and "Mechanical Engineering" aims to train professional profiles that have an important role in the economies of national and global construction industry.

Article 3

Participation requirements

Application for participation can be submitted by students of Politecnico di Milano who are enrolled, for the academic year 2019-20, to:
Master of Science (equivalent to Laurea Magistrale) Programme in Mechanical Engineering;
or
Master of Science (equivalent to Laurea Magistrale) Programme in Building and Architectural Engineering.

Article 4 Application for participation and submission deadline

Candidates have to submit their application at the following link: <http://www.polimi.it/servizionline> (Benefits and agreements > Economic benefits) not later of **27/07/2020**.

The applicant, under penalty of exclusion, must enclose the following documents (.pdf extension, max 10 MB) with the application form

- a) motivation letter;
- b) curriculum Studiorum of the Bachelor (included exams and abstract of the graduation work) or of the Master of Science (exam details, if available) Programmes;
- c) curriculum Vitae (With clear indication of other skills, professional experiences and hobbies).

Files must be named with Surname-Name-Type of Document.pdf (for example Rossi-Mario-curriculum.pdf).

The successful online submission is equivalent to its delivery and requires the applicant to be aware of the information sent. It is under the applicant's responsibility to verify the successful online submission.

Failure to complete the application or lack of required information will result in the exclusion from the assessment procedure.

Article 5 – Selection commission

The selection commission is appointed by the School of Architecture Urban Planning Construction Engineering and it is made up of at least three professors of the study programme in Building Engineering, Architectural Engineering and Mechanical Engineering chosen by the School.

Without the unanimity on the evaluation of candidates, the commission will ask for the unquestionable decision of the Dean of the School.

Article 6 - Assessment Criteria

The Selection Board proceeds to the selection, for which it can provide up to 100 points, through the examination of the documents submitted by the candidates and through the individual interview, according to the following criteria:

- Motivation letter: 10 points;
- Laurea (equivalent to Bachelor of Science) graduation score: 20 points;
- Academic curriculum for Laurea (equivalent to Bachelor of Science) and (if available) for Laurea Magistrale (equivalent to Master of Science): 40 points;
- Curriculum vitae: 10 points;
- Individual interview: 20 points.

Candidates are considered to have passed if they obtain a global assessment of not less than 60 points out of 100.

Article 7 Selection interview

To be admitted to the interview, candidates must show one of the following valid identity documents: identity card, passport or driving license. Absence or delay at the time set for the interview, even if due to force majeure, will be considered as a resignation of participation in the selection procedure. This call also constitutes notice of invitation to the interview.

Article 8 Merit ranking list

The Commission draws up, on the basis of the criteria and parameters set out in this call, a merit ranking list, taking into account the scores obtained in the evaluation of candidates.

Article 9 Data Treatment
